Summer Enrollment for Insurance Benefits and TexFlex is almost over! Summer Enrollment ends July 31, 2009.

ERS staff and benefits vendors will be traveling around the state to provide information and answer your questions to help you make decisions about your benefits at [Summer Enrollment Fairs](#). ERS recorded these presentations to make it easier for you to get information about benefits.

Summer Enrollment is our annual opportunity for benefits eligible employees to make changes to your benefits, such as adding dependents to health and optional coverage or signing up for TexFlex (PayFlex) or changing your TexFlex amounts. The changes you make will be effective for Plan Year 2010, which begins September 1, 2009.

The New HumanDental

On September 1, 2009, HumanaDental will be the administrator for both dental plans (Aetna, DMO and State of Texas Dental Choice). If you are not enrolled in dental insurance, you may want to enroll. You cannot enroll your eligible dependents in a dental plan unless you are also enrolled in the plan. You can also switch your dental plan.

If you are currently in the Aetna DMO, your coverage will automatically switch to the HumanaDental, DHMO on September 1, 2009. **You will need to select a primary care dentist (PCD) even if it's the same dentist that you use now. To select a PCD, go to ERS OnLine (or contact HR Benefits at 223-7800). Humana's network of providers is larger than the Aetna network.**

If you are currently in the State of Texas Dental Choice plan, your coverage will automatically switch to the State of Texas Dental Choice HumanaDental, PPO on September 1, 2009. To receive the maximum benefits at the lowest cost, visit a participating network dentist. If your dentist is not in the network, you still receive benefits, but you will pay higher out-of-pocket costs for the dental services.
