

## Web Committee Meeting Minutes - 9/06

The Get Answers section of the ACC website now has the capability to export FAQs contained in a category to an external website. The content is administered through Get Answers and is reflected not only in the Get Answers section but in the webpage the content is exported to. Health Science's Sonography Department is currently testing this.

Texas Administrative Code (TAC)§206 - State Web Sites is an administrative law which outlines requirements for state of Texas websites in four distinct areas: Accessibility/Usability, Privacy/Security, Required Policies, and Linking/Indexing of state websites. The statute was published in the Texas Register on March 15, 2002.
