We continue to work closely with TACC, CCATT, and GRAT, the state organizations of Community College Presidents, Community College Trustees, and Community College External Affairs professionals, respectively, to enhance efforts and create a synergy of our actions.

## Narrative:

One area where we have made a good deal of progress in the area of outreaching to local business and industry, through our External Affairs Outreach office. To date, that office has been responsible for establishing new relationships with forty local businesses, industries and nonprofits, often resulting in contracts being established for continuing education workforce training.

We are increasing, wherever possible meetings with local legislators to get their support of ACC efforts.

Our efforts to increase national visibility have been notable, in securing a White House Business Council Roundtable for ACC to host, of having representation on the White House focus group on Women and the Economy, and of planning a White House Roundtable in Austin for Women and the Economy, with ACC women Trustees, women members of Austin City Council, and women members of the Travis County Delegation of the Texas Legislature serving as hosts for the event.
