You must meet the following criteria to be eligible for Support Center services:

A. Expected Family Contribution (EFC) = 0 (determination based on FAFSA)

OR

B. Annual income for number of dependents is at or below current year's Federal Poverty Guidelines.

Steps 1 – 3: Check and attach each item to the application as you complete it.

Step 1- Provide Financial Aid or Income Information

From the Financial Aid Office (If not eligible for Financial Aid, see Income Information section on page 3 of application packet), include the following with your application:

NAIV database printout (if you have applied for your FAFSA more than 3-7 days ago)

OR

SAR (Student Aid Report) from FAFSA (if applied for Financial Aid for 2011-2012, but award is unknown)

Step 2: Apply for Childcare Payment Assistance

Step 3: Submit Application

Signed Application – turn in the completed application, along with the above information, to your campus Support Center.

In the event you are awarded assistance for childcare through the Support Center's payment assistance program, please be prepared to bring:

Proof of parentage for each child at the time you are awarded funding.

Examples of proof of parentage: birth-certificate, adoption papers
